#### **INTRODUCTION.**

This is an agreement, together with your Contract Summary, and any and all Renewal Notices (if applicable) (collectively, the "Agreement"), between Indra Energy ("Indra Energy" or "Indra") and you for natural gas supply service and/or electric generation supply service at each of the account addresses listed in your Confirmation Letter (or listed in an addendum). You agree to authorize a switch of your natural gas and/or electric supply service to Indra Energy and to purchase all the natural gas and/or electricity from Indra Energy required to service each of the accounts listed in your Confirmation Letter (or listed in any addendum) at a price as described in this Agreement. Indra Energy is licensed by the Maryland Public Service Commission to provide natural gas supply service (IR1803) and electric supply service (IR-1804).

#### PRICING.

# <u>Natural Gas and/or Electric Introductory Price (when applicable):</u>

You will pay an Introductory or Initial Price as set forth in your Contract Summary for the time period set forth in your Contract Summary. Thereafter, your price for natural gas and/or electric supply service will continue for the Contract Term at either a Variable or Fixed price as stated in your Contract Summary.

Natural Gas and/or Electric Fixed Price (when applicable): You will pay a Fixed Price as set forth in your Contract Summary for the fixed term indicated in your Contract Summary.

Natural Gas Variable Price (when applicable): You will pay a Variable Price for natural gas supply service that may vary from month-to-month as determined by Indra Energy in its sole discretion, based on the wholesale cost of natural gas to the Delivery Point, administrative and regulatory compliance costs, supply and agency functions that Indra Energy performs for you, and other prevailing business considerations and market conditions, plus Indra Energy's costs, expenses and margins. This list of factors is not exhaustive and no single factor will determine the rate.

#### **Electric Variable Price (when applicable):**

You will pay a Variable Price for electric supply service that may vary from month-to-month as determined by Indra Energy in its sole discretion based on the wholesale market prices acquired for energy, any supply and agency functions that Indra Energy performs for you, line loss, certain transmission, capacity, ancillary, administrative and regulatory compliance costs incurred by Indra Energy, alternative and renewable energy requirements, and prevailing business considerations market and conditions, plus Indra Energy's costs, expenses and margins. This list of factors is not exhaustive and no single factor will determine the price.

### Natural Gas and/or Electric Supply Price Disclosures:

Your natural gas and/or electric supply service price does not include, and you will be required to pay, applicable taxes and fees. Your natural gas and/or electric supply service price does not include your utility charges, for which you are responsible. Your variable natural gas and/or electric supply service price(s) may fluctuate from month-to-month and your Variable Price may be higher or lower than your utility's sales service or standard offer service rates in any given month. Indra Energy does not guarantee savings in any month or for the entire length of this Agreement. Indra Energy's current and historical prices are not an indicator of future prices. You may access your price for your next billing period at least 12 days prior to the close of your current billing period by visiting the Indra Energy website https://www.IndraEnergy.com/maryland-rates/. Energy may provide an estimated price for your next billing period and, if it does so, Indra Energy shall not charge a price for billing purposes that is higher than the estimate provided. There is not a limit on how much your variable natural gas and/or electric supply service price may change from one billing cycle to the next. The prices quoted in this Agreement are for the specified commodity(ies) provided by Indra Energy. The Maryland Public Service Commission does not regulate Indra Energy's natural gas or electricity prices.

### AGREEMENT TERM.

The initial term ("Initial Term") of this Agreement is set forth on the enclosed Contract Summary. Indra Energy will begin providing electricity and/or natural gas under this Agreement on your next meter read date after the Local Utility processes your enrollment and continue for the number of months/billing cycles as indicated on the Contract Summary page. After the Initial Term, unless otherwise agreed upon Customer's electricity and/or natural gas supply will automatically continue on to a variable monthly rate until Customer either selects a new plan or terminated this Agreement

as provided in the "Termination" below.

#### **TERMINATION.**

Indra Energy may terminate this Agreement for any or no reason by giving you 30 days' advance written notice before the effective date of such termination. You may terminate this Agreement for any or no reason at any time by: (a) calling (888) 504-6372; (b) sending a letter to 1515 Market Street, Suite 1200, Philadelphia, PA 19102; or (c) emailing CustomerCare@IndraEnergy.com. Upon termination as provided in this Agreement, you will be returned to your utility's supply service or you may choose another supplier. In any case in which your natural gas and/or electric supply service with Indra Energy is terminated as provided in this Agreement, you will remain obligated to pay for the natural gas and/or electric supply service provided by Indra Energy, and any other costs incurred by Indra Energy through the effective date of the termination. The effective date of termination will be determined by your utility.

#### **EARLY TERMINATION FEE.**

**Residential Customers:** There is no early termination fee for residential customers.

**Small Commercial Customers:** If you cancel your contract prior to the end of its term, you will be charged a flat fee of \$100.00 if there are 12 months or less remaining on the contract, or \$200.00 if there are more than 12 months remaining on the contract.

#### FIXED TERM AUTOMATIC RENEWAL.

At least forty-five (45) days before the expiration of your Fixed Term, Indra Energy will provide written notice to you of the Agreement's renewal ("Renewal Notice"). The Renewal Notice will set forth the proposed renewal option(s), including any applicable information required by the Commission. If you do not respond to the Renewal Notice or otherwise terminate this Agreement by notifying Indra Energy in accordance with the Termination section herein, then your Agreement will automatically renew on a month-to-month Variable Price in accordance with the terms set forth in the Renewal Notice.

#### **BILL PAYMENT.**

You will receive a single bill from your utility each month which will include the charges for Indra Energy's natural gas and/or electric supply service and for the services provided by your utility. You will make payment for all of these services directly to your utility. You will be billed for gas and/or electricity based on your consumption information that Indra Energy receives from your utility(ies) ("Billing Quantity"). Payment for gas and

electricity supply service is due to your utility in accordance with your utility's billing rules and procedures.

# <u>CUSTOMER INFORMATION PRIVACY POLICY & RELEASE.</u>

You authorize Indra Energy to obtain from your utility certain information needed to commence or continue to provide natural gas and/or electric supply service to you. This may include, but is not limited to, information such as, your utility account name, billing address, service address, utility account number, billing cycle, utility rate class or code, historical and future usage or consumption data including smart meter data, billing and payment history, credit information and public assistance status (collectively referred to as "Customer Information"). Indra Energy reserves the right to refuse to provide natural gas or electricity supply service to you under this Agreement if Indra Energy is unable to obtain Customer Information or it obtains Customer Information that it considers to be unsatisfactory. You authorize Indra Energy to release Customer Information to third parties that need to know such information in connection with your natural gas and/or electric supply service. This authorization will remain in effect throughout the term of this Agreement. You may rescind such authorization at any time by calling or providing written notice to Indra Energy. In the case of consolidated billing, you acknowledge that customer billing and payment information may be provided to Indra Energy.

#### TAXES.

You are responsible for paying and reimbursing Indra Energy for all applicable taxes, and other government fees, assessments, and charges, however designated, relating to the supply service provided under this Agreement. If you are tax exempt, you must furnish Indra Energy an exemption certificate before service commences.

#### **RESCISSION:**
